

## Schedule 1 – Promotion Terms

### PROMOTION TERMS AND CONDITIONS XIAOMI GWP PROMOTION

1. Subject to full compliance with these Promotion Terms and Conditions (“**Promotion Terms**”), an individual over the age of 18 (an “**Individual Participant**”) who is a legal resident in the United Kingdom or Republic of Ireland (“**Territories**”) or a company registered in one of the Territories (a “**Business Participant**”) and who between the 20<sup>th</sup> October 2022 (00:01 – BST) and the applicable end date indicated in Table 1 (either 26<sup>th</sup> October or 2<sup>nd</sup> November 2022) (the relevant “**Promotion Period**”) purchases a new (i.e. not used or second hand) eligible Xiaomi device as listed at Table 1 below (“**Promotion Product**”) from the relevant retailer listed at Table 1 below (“**Participating Retailer**”) will be eligible to receive as free of charge a specified gift reward as further detailed at Table 1 (the “**Reward**”). 10. The Promoter is not responsible or liable for any technical, hardware, software, server, website, or other failures outside our control that prevents the customer participating in the Promotion.
11. Participants who submit a Claim with incomplete information shall be notified via email and offered the opportunity to rectify any omissions or missing information within seven (7) days of their Claim being submitted.
